On the **317th day, in the year of Yahweh, six thousand and twenty four, translation the thirtieth day of January, two thousand and twenty three**, at approximately 7:17 p.m. Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20230130-SOS-OAR**.

BE IT RESOLVED, a motion for the following: The United States, in Congress assembled hereby proclaims an international objection on the public record to the existence of the Declaration of North America (hereinafter "declaration") published on (January 10th, 2023) by the Biden Administration Briefing Room in collaboration with Andrés Manuel López Obrador and Justin Trudeau. This declaration would potentially create a political subdivision superstate to claim power of attorney of millions of inhabitants, and is evidence in and of itself of the existence of Human Rights violations, including but not limited to trafficking in persons of thousands, throughout the borders of the metes and bounds and seaward boundaries of The United States of America; and

BE IT RESOLVED, a motion that the war crimes tribunal has supranational jurisdiction, which is international jurisdiction; and

BE IT RESOLVED, a motion to promote Brandon Scott Gibbs to the rank of captain within the continental army. Position accepted; and

BE IT RESOLVED, a motion to promote Alan Thomas Belanger to the rank of captain within the continental army. Position accepted; and

BE IT RESOLVED, a motion to promote Jeremy Christopher MacDonald to the rank of captain within the continental army; and

BE IT RESOLVED, the meeting for the National assembly adjourned on the **317th day, in the year of Yahweh, six thousand and twenty four, translation 30th day of January, two thousand and twenty three at approximately 8:39 p.m. Universal Time -6** to re-convene at a future date certain.

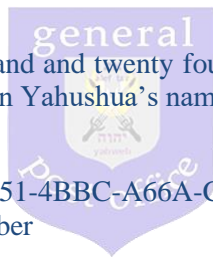
