## JUDGMENT

Comes now, a Judgment and Order from **The Human Rights Tribunal International,**

WHEREAS, the claimant has claimed within the evidence submitted to this tribunal based on Affidavits of Fact and having a True Bill of Indictment as a second witness that the Respondents have and continue to commit violations against the Universal Declaration of Human Rights, and in violation of all of Public Laws-101.

WHEREAS, the claimant has claimed multiple violations under the Universal Declaration of Human Rights on all Thirty (30) Articles of the UDHR, and a violation of all of Public Laws-101.

WHEREAS, **the True Bill of Indictment connects each of the named Respondents to the role that they play in the Leaving the Claimant in continual servitude to the Respondents.**

Communism/Political- a violation of all Thirty (30) Articles of Public Laws-101 (War Crime)

Persecution/Political- a violation of all Public Laws-101 (War Crime)

Forced Association- a violation of Public Law-101-4, and Public Law-101-20

Trafficking/ in Persons- a violation of all of Public Laws-101 (War Crime)

Violation of Article 1 of the Montevideo Convention

Freedom of Movement- a violation of Public Law 101-13-1

Aiding and Abetting- a violation of Public Law 101-7

Armed Theft- a violation of Public Law-101-2, and Public Law-101-3



Extortion- a violation of Public Law(s) 101-3, Public Law 101-5, Public Law 101-7, Public Law 101-12, Public Law 101-17-1 and Public Law 101-17-2

Slavery- a violation of all Thirty (30) Articles of Public Laws-101 (War Crime)

Infiltration of a State- a violation of all Thirty (30) Articles of Public Laws-101 (War Crime)

Violating the Law of Nations Book I, Chapter XIII Of Justice and Polity § 158 A nation ought to make justice reign (Capital Crime) International.

Whereas, violation of all 30 articles of UDHR assessed value- 22.5 million the Respondents have committed multiple Human Rights violations against the Universal Declaration of Human Rights.

Whereas, the Respondent(s) are not recognizing the intangible rights of Claimant and demeaning Claimant as an inhabitant. The Respondents do not have the right to ignore the change of claimant's political status to American National and North American National Party (NANP) member. The Affidavit of Fact from the Claimant shows that the Claimant is an affirmed American National and NANP member and is no longer considered an inhabitant or a United States Citizen.

Whereas, Respondents have committed Armed Robbery and Theft upon Claimant for the armed seizure and theft of Claimant's private property in the form of a silver (2010) Ford Ranger Vehicle Registration Number: 1FTKR4EE0APA22373 evidenced in Point 6 and Exhibit 5 on pages 11 through 17 within Affidavit #1, in response to (Foreign STATE OF INDIANA, Gibson Superior Court Cause # 26D01-2208-IF-2274).

Whereas, Eric Holcomb as Respondent and Holli Sullivan as Respondent are holding offices in a private, corporate, legal society (STATE OF INDIANA) using foreign emoluments in the form of private Bank Notes and Security Instruments as weapons for committing forced association and slavery upon Claimant, and shall be held accountable for all injuries incurred by Claimant including but not limited to armed robbery, denial of Nationality, and extortion of Claimant's private property. Respondents are Human Rights Violators and found guilty upon the evidence furnished and Respondents failure to appear for this adjudication.

All Respondents are complicit in violation of all Public Laws – 101 the moment Respondent Jennifer Robb, armed foreign registered agent, wrote Claimant a ticket thereby denying Claimant a Nationality, and Trafficking in Persons violating the codified Law of Nations Book I Of Nations Considered in Themselves Chapter XIII Of Justice and Polity § 158. All Respondents are guilty of trafficking the Claimants Person from the survey called The United States of America to the United States Federal Corporation's jurisdiction against the Claimants will and written objection from the North American National Party (NANP).

Whereas, the Respondents were given multiple opportunities to correct the record when each of the Respondents were noticed and witnessed that the Claimant's credentials were proof that



Claimant is foreign to the Respondents political venue. Respondents failed to retract all charges that had no standing and failed to return Claimant's Private Property.

## JUDGMENT SUMMARY

NOW THEREFORE:

BE IT JUDGED, that the claims brought to the Human Rights Tribunal International gives witness to the existence of Human Rights Violations against the Universal Declaration of Human Rights and violations of all of Public Laws-101 have occurred and that the evidence presented in the True Bill of Indictment proves that Respondents did repeatedly dishonor the two affidavit of fact (communications) of the Claimant. The fact that the Respondents have continued forced legal proceedings in Respondents private Judiciary, without any judicial authority over the Claimant highlights the nefarious intent of these Respondents. Slavery is outlawed in all its forms and will not be tolerated by this court.

## Orders

BE IT ORDERED, that Respondents are in violation of all Thirty (30) Articles the Universal Declaration of Human Rights, and a violation of all of Public Laws-101. Violation of all 30 articles of UDHR has been assessed in value of 22.5 million over and above any violation of the federal common law lien that was a trespass by the respondents in the repeated attempts to traffic the Claimant as an inhabitant or U.S. Citizen, and

FURTHER BE IT ORDERED, that Claimant be compensated financially in the amount specified for violating each article of Public Laws-101, not in Fiat currency but in full title to tangible land property assets released by the Crown and or authorized U.S. agents to Claimant. Said land property assets shall be under the maxims of equity subject to the venue and jurisdiction of the republic form of Government, The United States of America.

FURTHER BE IT ORDERED, that any further evidence of violations of the UDHR or any other deprivation of character will be sent to the Law Department for the Government of The United States of America for further review for possible further Human Right Violations under international law, and

FURTHER BE IT ORDERED, that no retaliation or harassment against the Government of The United States of America, its office holders, or any other American National shall be tolerated, any and all retaliation by any and all shall be resisted with automatic arrest of the Human Rights Violator and tried in this Human Rights Tribunal immediately upon a proper affidavit and evidence to support the violation, and



FURTHER BE IT ORDERED, that the Law Department for the Government of The United States of America reserves the right to utilize this Judgment and Order and all evidence herewith in any future charges or court actions in this or other court of Law.

FURTHER BE IT ORDERED, that this Judgment and Order be sent to The office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America For the purpose of attaching a fine for the monetary damages associated with Violations of all 30 Articles of the Universal Declaration of Human Rights.

## GENERAL ORDER

FURTHER BE IT ORDERED UNDER GENERAL ORDER: that any and all Foreign Monarchs, Governments, incorporated and/or unincorporated Associations, Agencies or agents thereof are hereby ordered to cease and desist any and all interference or disruptive actions towards The United States of America, the Government of The United States of America, American Nationals, the Social Compact Agreement of its Nationals, the power of attorney, its Law form, and freedoms thereto, and

Affirmed and Acknowledged by the Human Rights Tribunal on this 342<sup>th</sup> Day in the year of Yahweh 6024 Translation (24<sup>th</sup> Day of February 2023)
