### Official Assembly Record

**BE IT RESOLVED**, a motion to amend Article 24 of the Constitution of the War Crimes Tribunal for The United States of America from “The Tribunal shall have the right to impose upon a Respondent, on conviction, death or such other punishment as shall be determined by it to be just, and” to read as; “The Tribunal shall have the right to impose upon a Respondent, on conviction, banishment and/or exile from the metes and bounds and seaward boundaries of The United States of America or such other punishment as shall be determined by it to be just, free of a death sentence to allow a Respondent time to reconcile with our Heavenly Father through His Son Yeshua, keeping in step with the Set Apart Spirit” and

**BE IT RESOLVED**, a motion to amend all prior Judgment and Orders issued by the War Crimes Tribunal for The United States of America through International Public Notice wherein all Respondents have been found guilty and sentenced to death by firing squad, to reflect a sentence of exile from the metes and bounds and seaward boundaries of The United States of America as stated within Article 24 of the Constitution of the War Crimes Tribunal for The United States of America as amended by the National assembly on the 4th day in the Year of Yahweh 6025 and the 23rd day of March in the two thousand and twenty third year of the new covenant in Yahushua’s name; and

**BE IT RESOLVED**, the meeting for the National assembly adjourned on the **7<sup>th</sup> day, in the year of Yahweh, six thousand and twenty five, translation 27th day of March, two thousand and twenty three at approximately 9:13 p.m. Universal Time -6** to re-convene at a future date certain.
