Official Assembly Record

BE IT RESOLVED, a motion to change reign of the heavens from a country to dominion; and

BE IT RESOLVED, a motion to convert the North American National Party into a succession party; and

BE IT RESOLVED, a motion to create a port of entry; and

BE IT RESOLVED, a motion to create a general delivery route and an economic zone by and between the reign of the heavens and the United States of America. Through the document and precedent, it would be under common law; the precedent of doing a declaration of an existence of a name; and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 36th day, in the year of Yahweh, six thousand and twenty five, translation 24th day of April, two thousand and twenty three at approximately 8:56 p.m. Universal Time -5 to re-convene at a future date certain.
