

**BE IT RESOLVED**, an oath of office was given by a General Post Master to Shelley Renee Foster for office of Interim Secretary of the American National assembly of The United States of America, and

**BE IT RESOLVED**, an oath of office was given by a General Post Master to Tina Sue Beck for office of Interim Treasurer of the American National assembly of The United States of America, and

**BE IT RESOLVED**, the meeting of the American National assembly of The United States of America adjourned on this **6<sup>th</sup> day in the year of Yahweh, six-thousand and twenty-six, translated, 25<sup>th</sup> day of March, two-thousand and twenty-four at 8:35 PM UTC-5** to re-convene at a future date certain, and
