BE IT RESOLVED, a motion to adjourn the assembly tonight; and

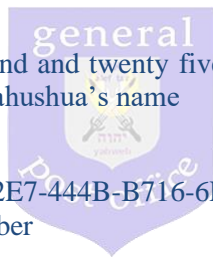
