**BE IT RESOLVED**, the trustees of the reign of the heavens hereby grants the reign of the heavens citizens authority to use the General Post Union; and

**BE IT RESOLVED**, the name and style of this assembly will be the assembly of Elohim; and

**BE IT RESOLVED**, a motion to adopt the constitution of organizing our commercial activities; and

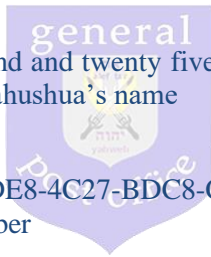
