Rebuttal of Libel, Slanderous and Falsified Statements and Opportunity to Cure

In response to the egregious, defamatory and libelous statements made by Keith Livingway, (a.k.a. James Faith) in the above-referenced publication about me, Heather Bingham, and others who joined in lawful assembly with me, I write this rebuttal in response, and gift this Opportunity to Cure. Your publishing is slanderous and false, and has no truth in it whatsoever.

The persons named in this rebuttal <u>pretended and continue to pretend</u> to be of service and helpful to all who come to them, by initially answering questions, offering individual trainings / sessions to teach about TUSA, and personal invitations to join TROH, etc.;

The persons named in this rebuttal <u>act like</u> they are benevolent and humble by supporting the reading of the scripture Matthew 5:23-24 at the beginning of each ANA meeting which states "If, then, you bring your gift to the altar, and there remember that your brother holds whatever against you, leave your gift there before the altar, and go, first make peace with your brother, and then come and offer your gift", (The Scriptures), giving the appearance that they offer peaceful reconciliation and forgiveness; and

The persons named in this rebuttal <u>initially give the appearance of</u> supporting freedom of religion and worship, i.e. by claiming these fundamental rights to be defended in their Bilateral Social Compact;

The persons named in this rebuttal <u>presented and continue to present</u> the Bilateral Social compact, which is connected to TUSA, as a document which can be used by people desiring to enter a trust for lawfully occupying the metes and bounds of The United States of America, and that it is available to all, without causing harm.
