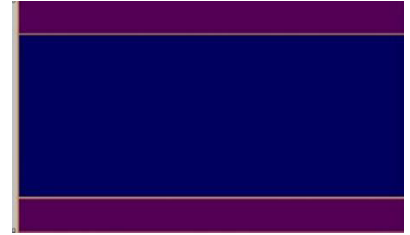

document rebuking political Islam, and

Islam passed at 7:54pm UTC-6, and

**BE IT RESOLVED**, Shel Volney motioned to adjourn the quorum, and



**BE IT RESOLVED**, Lillian Harvey seconded the motion to adjourn the quorum, and

**BE IT RESOLVED**, the meeting of the American National assembly of The United States of America adjourned on this **61st day in the year of Yahweh, six-thousand and twenty-seven, translated, 19th day of May, two-thousand and twenty-five at 7:55pm UTC-6** to re-convene at a future date certain, and
