### Real ID and Biometric Objection



We, the American National assembly, within the metes and bounds and seaward boundaries of The United States of America, in social compact, (hereinafter “the assembly”), are followers of Yeshua/יהושע/Messiah/Jesus Christ, The Way, The Truth, and The Life, and

We, the assembly, petition in Yeshua’s name, for a redress of grievance of The Real ID and we object to the creation and use of The Real ID in its entirety, and further The Real ID Act of 2005. The Real ID Act of 2005 violates the jurisdiction of religion. The political subdivisions do not identify the assembly. Only יהושע can recognize and grant an identity. The Real ID created by the political subdivision, interferes with the private relationship with יהושע, and asks for specific allegiances that don’t exist, and

The Real ID is connected to facial recognition which violates privacy, human rights, and is considered identity theft, creating a greater number of victims, it restricts what can be purchased and how it can be purchased, the access to different forms of currency, or medical care and support, and can be used for data mining purposes which is discrimination of human rights and communist totalitarian control, and

The Real ID is a violation of The Law of Nations and of the Universal Declaration of Human Rights violating Articles 3, 4, 12, 13, 18, and 20 (LINK), and

We, the assembly, believe the Real ID is a form of the mark of the beast. In the book of Revelation 13:16-17 describes the mark of the beast as follows:

“<sup>16</sup> And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads:

<sup>17</sup> And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.”
